4. Details of our assessment

On 31 January 2023 a site inspection was undertaken at Derwen RRF by Sally Wakeford. At the time, Derwen were hosting NRW for some Audit training. This Compliance Assessment is not connected to the training, and is an assessment carried out separately.

A walkover site inspection was carried out with Stuart Hanford.

Some significant works had been completed near the front of the site, with the removal of material to near site floor level.

Fines:

Discussions were held over the fine clay material from the process. At present it is being used for various daily cover in landfills. However, with changes in the landfills occurring, in a few years' time this will become an issue again. Derwen are hopeful that a lot of this material will be able to be taken to Pwllfawatkin Landfill for the capping of the landfill. Derwen should consider some succession planning for what will happen to this material once the current options are closed.

River side boundary:

On the last inspection it was noted that the waste on the river side of the site had the potential to enter the watercourse. During this inspection it was noted that works had been undertaken to pull this waste back, and Derwen were in the process of completing this work further along the bank where vegetation provided some protection. Derwen are considering placing a fence along this boundary, using the upright posts already in place. Please ensure that the waste remains inside the permit boundary and does not enter the watercourse.
