4. Details of our assessment

This was an announced site inspection, carried out by Natural Resources Wales officers Donna Muirhead (Waste Regulation Officer) Euros Jones (Operations Manager North).

Accompanying officers throughout the inspection was Endaf Williams and Susan Francis.

Weather conditions throughout the visit were dry and sunny.

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

The material recycling facility was operational with recyclables being processed.

All wastes were appropriately stored in the storage bays outside the building. There was street cleaning residue stored in the designated bay at the time.



The storage yard at the lower end of site near the weighbridge had some baled materials stored, and was also neat and tidy.



Residual waste was being stored in the residual waste transfer unit. No odour was detectable from outside the building, a few seagulls were present near the site.

The civic amenity site was operational with members of the public depositing waste into the correct waste receptacles with Operatives on hand to assist the public. This area was tidy and organised.

Site surfaces were clean and tidy.



No issues were noted relating to noise, dust, odour, litter, vermin or deposits on the highway.
