During a routine compliance assessment check we have carried out on 07/03/23 it was noted that the Improvement Conditions information returns for EPR permit CM0168501 PEN Y FFORDD ADJ PEN Y FFORDD had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.
