4. Details of our assessment

A routine site inspection took place on Wednesday 22nd February 2023.

Waste Regulation Officer Sarah Walton, met on site with site operative David Griffiths. The weather at time of inspection was generally dry with some hail showers.

A review of Waste Returns was completed prior to the inspection. Thank you for the timely submission of these reports. No issues were found during the review.

David explained operations at site. Skips generally come into site and are then tipped at the back of the sorting shed. Waste is then picked by hand to remove items such as wood, metal and plasterboard. Residual waste is regularly removed from site (usually every day or two) due to the size of the sorting shed. Therefore, there is quite a quick turnaround meaning waste is never sat for long. Most of the waste is moved onwards to Tudor Griffiths based in Ellesmere Port.

Soil and rubble also sometimes come in with the skips. This is separated out and stored in skips outside opposite the sorting shed. Some of this waste is moved to the waste site next door (Old Bridge Inn) and also Tudor Griffiths.

There were a number of mattresses being stored on top of the office shed roof.

Action: Please ensure this waste is stored undercover in a building as per permit condition 2.3.1 (Table 2.3)
