Natural Resources Wales officer Ffion Jones met with poultry operator Mr Martyn Langford to carry out the routine poultry inspection on the 23rd February 2023 at 11am. Thank you for your time during the site visit.

Action Management Plan

Please ensure an emergency contact list, a drainage plan and a raw materials list is attached to the Accident Management Plan. Please provide a complete copy of the Action Management Plan in an accessible location e.g. box outside permitted area by 22nd March 2023.

The Drainage Plan must include site layout drawn to scale, direction of flow, dirty water tanks/channels, clean water tanks/channels, diverter valves, surface and foul drains, identify sensitive receptors and any environmental hazards.

The Raw Materials List should include any raw materials that are used within the permitted area, maximum amount that is likely to be stored at any one time, annual throughput and description of use.

Poultry litter/manure analysis:

When manure and slurry is spread on own land, they must be analysed to provide information for nutrient management planning. Records should show that analysis is carried out twice yearly, or once per production cycle where that cycle exceeds six months. The analysis should include available nitrogen, total nitrogen, available phosphorus and total phosphorus. *NRW are aware that you do not spread poultry litter directly to land however, it was mentioned during the inspection that analysis had been conducted. Please provide the manure analysis report to NRW by the 22nd March 2023.*
