4. Details of our assessment

Aluminium Breach - South Caernarfon Creamery

A schedule 5 notification has shown a breach of permit limit for effluent discharge from your facility into the Afon Erch. The breach in question on this occasion is for Aluminium. This breach was sampled on the 01/03/2023

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for Aluminium is 1.0 mg/l and the value reported was 1.33mg/l

The result is more than 30% over the permitted limit and is therefore in the context of this discharge is considered a minor breach.

The CCS score on this occasion is a CCS 3.
