## 4. Details of our assessment

An unannounced, routine inspection was carried out by Cathy Lloyd of Natural Resources Wales.

The site was clean and tidy and storage areas were clearly signposted. The waste was well segregated and the site infrastructure appeared to be in good condition.

### **Storage, Handling, Labelling and Segregation**

One skip containing clean metal waste was being stored on a hardstanding area. This is a category 3 breach of Condition 2.1.1 Table 2.1 *All waste must be kept on an impermeable pavement with sealed drainage.*

**Action:** Please ensure all waste is kept on the impermeable pavement.
