During a routine compliance assessment check we have carried out on 09/03/2023 it was noted that the Improvement Conditions information returns for EPR permit S/01/07909/O

Llanfair Caereinion - Railway Stn, Penybontfawr, Carno, Llanfyllin - Ffordd Y Cain CSOs had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred. Actions – please carry out the actions specified above to comply with permit condition 2.4.1. It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
