4. Details of our assessment

This compliance review was carried out by Malcolm Dines on 10th March 2023. Previously you have stated that you do not currently accept waste as a feedstock for the plant. As part of Natural Resources Wales (NRW) routine compliance work there is a requirement to review your quarterly waste returns and your compliance with an approved technical

competence scheme. Additionally NRW identified a pollution near to this site on 9th March 2023 and in a telephone conversation with yourselves on that day, you confirmed to Malcolm Dines that you were not accepting waste as a feedstock into the anaerobic digestion process.

Permit Breaches

C1 - Staff Competency/Training - Action Only; Permit Condition 1.1.4

Our current records show that the previously submitted Technical Competence certificates for the site were dated 2019 and 2020. The initial technical competence qualification lasts for two years after which you must demonstrate your competency by passing the relevant Continuing Competency award for your site every two years. Please submit a copy of your current up-to-date certificates before 20 March 2023.

The failure to comply with an approved competency scheme is a breach of permit condition 1.1.4. Compliance with this requirement will be assessed in a subsequent Compliance Report.

Other Comments

The review of your waste returns show that you are submitting 'Nil Returns' and are compliance with permit condition 4.2.2.
