4. Details of our assessment

Officers Natalie Wrangham, Paul Latham and Emily Roe met with Chris Barber on the 10/02/2023 to inspect the water discharge from the disposal point C into the Nant Gyrawd after submission of an incident report from the member of the public regarding discolouration to the watercourse.

The stream was previously visit on 02/02/2023 to check the watercourse after the report, near the old cottages at the confluence between the Gyrawd and the Taff Bargoed. No discolouration seen, however follow up site visit was considered appropriate.

Point Manager Andrew and his colleague Phil showed us the outfall from the lagoons and the discharge into the stream under the railway bridge. At both points the water appeared clear. Some staining /deposition in the stream bottom, however this is considered to most likely be from the previous incident from the site in 2021.

Sample results from 24th January submitted to Officer Wrangham by Stuart Thomas show readings within the permitted range. Spreadsheet saved to Document Management System for records.
