During a routine compliance assessment check we have carried out on 16/03/2023 it was noted that the Improvement Conditions information returns for EPR permit EPR/BB3895ZN CSO at End of Railway Terrace, Ogmere Vale had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.

Actions – please carry out the actions specified above to comply with permit condition 2.4.1.

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
