4. Details of our assessment

A final inspection was undertaken at Carmarthenshire Recycling Company Limited, Johnstown depot permit number VP3698FD. The final surrender inspection was undertaken by Sally Wakeford and Michael Launder.

The site has not been occupied by Carmarthenshire Recycling for approximately 3 years. The site gates were open, there was no waste left outside the building.

The doors to the building were open, and occupied by 3 vehicles, which were not related to Carmarthenshire Recycling or waste processing machinery/vehicles. There was no waste within the building.

There was no evidence that the waste operation has had any environmental effect on the site.

The sign for the site has been removed.

I am content this is a low-risk surrender, and the site is completely vacated by Carmarthenshire Recycling Company Limited and there is no ongoing environmental impact from the activity undertaken under the permit.
