Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

A site visit was carried out on the 22/08/2022 for the abstraction on the Afon Clochnant to ensure this was compliant with the conditions in the licence during low flow conditions.

As no abstraction was taking place, all the water appeared to be going through the hands off flow notch. Therefore, no measurements were taken of the flow to ensure minimum flows were achieved as per the licence. This is compliant with licence condition 9.5 which

states:

- (i) No abstraction of water shall take place unless the rate of flow in the Afon Clochnant immediately downstream of the authorised point of abstraction, marked as 'Point A' as specified in Condition 2.1, is equal to or greater than 23 litres per second and the abstraction shall not cause the flow immediately downstream of said abstraction point to fall below that rate.
- (ii) The quantity of water abstracted shall not exceed 75% of the available flow in the Afon Clochnant in excess of 23 litres per second.

During the inspection, it became apparent that we had the incorrect version of the licence which contained incorrect measurements and drawings. Therefore, a further visit will be carried out in the future to assess the correct measurements in the newest version of the licence - This will be assessed against condition (9.2) The Licence Holder shall construct, operate and maintain the hydropower scheme in accordance with the specifications and drawing: 'AFON CLOCHNANT INTAKE P89 206 R3'.
