4. Details of our assessment

Notification of exceedance

Following routine monitoring on the 4th of March 2022, results from the final effluent samples provided the following readings:

Suspended Solids 78 mg/l the permitted limit is 60 mg/l.

Breach of permit condition Upper Tier failure permit condition 3.3.1 schedule 3:

Biological Oxygen Demand 81 mg/l upper tier limit is 80 mg/l.

These results are the first exceedance for the works in a twelve-month period. Please investigate reason for exceedance and provide explanation to Natural Resources Wales with 4 weeks of receipt of this CAR form.
