DCWW have undertaken a full RCA and with additional measures in place to prevent a recurrence – the works was seeing increased Turbidity in the supernatant water due to weak Polymer batch strength, this resulted in increased effluent flows and subsequently insufficient dichlorination. I will be at the Pembs liaison meeting tomorrow so we can run through the detail on the Preseli WTW and fully respond to the CAR in due course (Lisa Elworthy 15/03/2023)
