4. Details of our assessment

On 22 February 2023 a site inspection was undertaken at A J Recycling Limited, EPR/JP3998FN. Sally Wakeford was accompanied on site by Sonia Jenkins.

This was undertaken as a general site and a Materials Facility inspection.

A small amount of incoming mixed Recyclates were on site. The site mainly accepts mixed Recyclates, and separately collected cardboard, carpets, hard plastics, and some black bag waste (20 03 02).

The rear shed is used for storage only, with baled carpets and paper/card, along with unbaled paper/card.

The site was generally very clean and tidy.

The drainage system was checked and appeared clear of debris.

C4 – Storage, handling labelling and segregation – Permit condition 4.2.2 – CAT 4 breach

During the inspection it was noted that quarantined waste which had been removed from incoming wastes was deposited on the floor outside the building. Permit condition 4.2.2 states that quarantined waste should be placed in a container. There was no environmental impact from this breach as it was stored in an area of sealed drainage. A category 4 breach has been marked against permit condition 4.2.2.

This was discussed via email correspondence with Sonia Jenkins, and already rectified.

MRF:

Input wastes were consistent, and of a high-quality mixed cans and plastics. The wastes appeared consistent with the sampling undertaken in the recent waste returns.

Output wastes in the bays from the picking line were very consistent, with no contamination of other wastes noted.

Output bales also appeared consistent with the sampling undertaken on the output wastes of the recent waste returns.

The sampling table was still operational as it has been previously, with scales calibrated at the same time as the weighbridge on a yearly basis.

Thank you to Sonia for taking the time to accompany me on site.
