4. Details of our assessment

On the 7th of March 2023, NRW officers Nathan Owen and Cathrine Kiley accompanied by Cheryl Griffiths.

The weather on the day was bright sunny & dry.

NRW where met at the site by Michaela Thompson and her colleagues.

The inspection began with a view of the inlet which appeared to be in good working order, the skip on site where the waste solids are deposited had a hole in the base of the skip, allowing waste materials and liquids to be discharged to the concrete pad in place. See

The next area visited was the settlement and filter beds, all appeared to be in good working order with flow being passed forward, there was no growth on the filter bed. See image



There was water leaching from the base of the filter bed, can DCWW clarify if this is a maintenance issue or part of the operation? See image



The outfall was clear of any fungus and no off-colour water was witnessed going into the watercourse at the discharge point.

NRW are requesting MCERTS data for this site from the period of 1st of August 2022 to

March 1st, 2023. Please can DCWW provide this information in a timely manner.
