### 4. Details of our assessment

Angharad Clark met with Mathew Roderick at Browns Waste Management and Recycling Ltd on 15th February 2023.

Mr Roderick has submitted a Fire Mitigation and Prevention Plan for review.

The piles of burned waste which remained after the fire last October were greatly reduced

and the drainage on the site has improved since my last visit.

There was a large number of seagulls present at the site at the time of my visit. I advised Mr Roderick that this needs to be addressed.

There was also a waste odour evident outside the site boundary. This is in contravention of permit condition 3.2 and has been marked as an action. Please provide an odour management plan to NRW by 22nd June 2023.
