4. Details of our assessment

A site inspection was undertaken on Wednesday 22nd March 2023. Present on site during the inspection were David Morgan (Natural Resources Wales) and Mr. Richard Jenkins (Operator).

The inspection was part of the routine regulatory programme for Natural Resources Wales,

however, in the previous inspection (15th March 2022), two actions were required to be completed.

The following observations were made during the inspection of Wednesday 22nd March 2023:

Previous Inspection & Actions

In the previous inspection it was noted that operations were on hold as the 3-year rolling planning permission had not been finalised. It is assumed that once this planning matter is finalised, operations will recommence.

The two actions required to be completed following the previous inspection were:

* Provide written formal update of position with regards to planning - COMPLETE (assessed 29/06/2022)

* Ensure works are undertaken to repair/maintain boundary fence - COMPLETE (assessed 22/03/2023)

These actions are assessed as complete and operations are deemed to be fully compliant with the Environmental Permit.

Planning & Recommencement of Operations

Please notify Natural Resources Wales if/when the planning matter is resolved and operations resume on site. Also, please ensure waste returns information continues to be submitted, even if operations are temporarily paused.

No non-compliances were recorded during the inspection and operations are deemed to be compliant with the Environmental Permit.
