4. Details of our assessment

This Compliance Assessment Report follows the review of Q4 (October- December 2022) monitoring data. This data was received by NRW on 16/01/23 which is within the timescales required by the permit.

All parameters were compliant with the permitted Emission Limit Values (ELVs).

It should be noted that Emission point W1 recorded elevated Chemical Oxygen Demand (COD) levels of 81 mg/l vs an ELV of 70mg/l on the morning of 19/10/22. NRW were immediately notified of this temporary COD elevation and do not consider this a permit breach for the reasons discussed below.

The permit requires that daily spot samples are taken at W1 and W2 to monitor COD. On 19/10/22, the operator took a sample at W1 at 06:22 which recorded a value of 81mg/l for COD. The East balancing pond was closed immediately and a site investigation commenced with no issues or incidents identified. A further sample was taken which recorded a COD value of 30mg/l. The East balancing pond was reopened at 14:30.

On 20/10/22, sample results from W1 recorded a value of 59mg/l COD. Sample results preceding 19/10/22 do not indicate elevated COD - 16/10/22 -37mg/l, 17/10/22-11mg/l, 18/10/22-1mg/l.
