The purpose of this meeting was to introduce the new Environmental Engineer to Natural Resources Wales, (NRW).

Present at the meeting were -

Rebecca Green, (RVG), PPC Compliance Officer, NRW.

Various improvements to the site and expansion plans for the manufacturing areas were discussed. There may be a need for NWF to apply for a permit variation sometime this year.

The feasibility of starting a discussion group between the "Neptune 6" group of semiconductor manufacturers and NRW was also discussed.

MCPD and the relevant BAT emission limit values will apply to one of the proposed improvements but it may be possible to add this improvement to the existing installation permit as a Directly Associated Activity (DAA). However, given all the changes proposed on site, it may be better to try to combine them all into one variation. Permitting will need to be consulted so that NWF know what type of variation is applicable.
