The annual EMS Review for 2018 was received on 22nd February 2019.

The report is accepted.

This is a comprehensive report on the various targets set for 2018. Almost all of them have been achieved or are on-going.

An external noise survey is planned for 2019 and Natural Resources Wales (NRW) would like to receive a copy of the final report.

There has been a reduction in the sludge volume sent for disposal due to better use of the filter press. This is a very encouraging result. The project will be continued in 2019.

Aluminium contaminated filter papers are now collected separately for disposal.

There is an on-going problem with the disposal of used chemical containers which affects the whole surface treatment industry. NRW will try to assist TRW in finding alternative routes for recycling.

The treatment of knotweed continues and will be extended into the field at the rear of the plant.

It would be interesting to see the effects of using larger anodes once data is available.
