### Monitoring reports

Q3 report, 2018 Annual Report (includes Q4) received and reviewed.

Leachate monitoring – permit condition 2.7

No breaches in the average value across the monitoring points (3m compliance limit)

However, report sections 5.2.1 and 5.2.2 recommendations noted and agreed with respect to the general increasing level in LC5A. SVWS have provided details for further investigation and additional testing. This includes well pumping or a replacement well; drilled as part of in-waste contract (subject to interest / availability of drillers)

Also noted increasing trend of ammoniacal nitrogen and Ni leachate quality above the AMC in LC5A. SVWS have provided contingency plan investigation details/proposals in line with above. Further details to follow. **Please provide Technical Note** by end of February.

Groundwater monitoring - permit condition 3.1.5

Historical levels of metals noted, refer to previous correspondence.

Options for replacement of GW11A near the waste transfer station discussed and agreed. Further details with timetable to follow (this is currently subject to interest / availability of drillers)

Groundwater monitoring borehole GW9 records continued non-compliance for ammoniacal nitrogen.

Score CCS3 suspended in GW9, agreed requisite monitoring on-going.

Trends in GW6 also noted.

Separately, SVWS to provide **Draft HRA Review** by end of February.

Surface water monitoring - permit condition 3.5

No non-compliances; though noted dry locations at sampling points.

Reports include revised assessment method for surface water, as developed by WFD UKTAG. This is known as the 'Metal Bioavailability Assessment Tool' (M-BAT)

Report section 4.3.1.2 noted with respect to Zn results and down gradient sampling points. We agree with recommendations to review results (represent an increase, or an anomaly)

Landfill gas monitoring - permit condition 3.1.7

No non-compliances for methane, though report section 5.4 recommendations noted and agreed for replacement of monitoring point GMW14. **Action** SVWS to consider doing this work whilst the drilling rig is on site for groundwater well GW11A.

**2018 Flare emissions report, Trace gas analysis**

Reports received and reviewed.

We agree with the findings of the flare emissions report (note 4)
