3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

On Thursday the 23rd of March 2023 Natural Resources officers attended at City Metals to conduct an unannounced site inspection.

The site was last inspected on the 28th of September 2022, Compliance assessment form NRW040470 refers.

The officers met with Craig, the site manager, who accompanied officers throughout the inspection.

The site is operational; however not many vehicles are being processed at the moment due to current market trends.

The storage area was checked and no issues were noticed.

Waste returns:

Condition 7.2.2 of your permit requires you to submit within one month of the end of each quarter a summary of waste quantities and types accepted on to and removed from site for that quarter.

Q4 2022 has not been submitted, this has subsequently been scored as a C4 breach against the relevant permit condition.

Action: Please submit the outstanding waste return by no later than the 14th of April.

Site diary

Condition 7.3.1 Describes all events that need to be recorded in the diary including start and finish of daily waste management activities, emergencies, technical competent management attendance on site.

Site diary was inspected and it became apparent that only end-of-life vehicle details are currently being recorded. This has been raised during the last site visit.

It has subsequently been scored as a C4 breach against the relevant permit condition

EMS/Working Plan

NRW received a draft EMS for the site which has been returned with several comments.

We have not received your updated version. The EMS has been discussed with the site TCM who agreed to liaise with the site owner.

Action: Please update and send your EMS for assessment. Please comply by the 28th of April

After the inspection officers attended at the City Metals office and spoke to Mike, TCM for the site, to discuss the inspection and actions needed.

Officers mentioned that during the last site inspection a lorry containing wooden pallets was present on site. Mike stated that he would liaise with the site owner to clarify the above.
