4. Details of our assessment

Introduction

This report details the site visit made on the 22 March 2023 to Gibbon Equipment Hire site at Unit 12, East Road, Penallta Industrial Estate, Ystrad Mynach CF82 7XH, Permit number EPR- FP3195FC. NRW Officer Carla CURTIS attended site at 10:30 to conduct a routine inspection. The last inspection of this site was completed 4 February 2021 (CAR_NRW0037501). Miss Helen LLOYD (TCM) accompanied officer around the site. Weather conditions were mild and sunny at the time of inspection. The site was accommodating and cooperative during the site inspection

To remind the company following each visit Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions which can affect your site banding annual subsistence fees; this is scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

Observations

Gibbon Equipment Hire Ltd operate under a bespoke environmental permit for the storage of septic tank sludge, code - 200304 in the EWC (European Waste Catalogue) - chemical toilet waste only. The site was in operation at the time of the visit. No waste of any type was stored outside of the permit boundary and there were no offensive waste odours or excessive noises noted by NRW Officer CURTIS during the site inspection

There were numerous storage containers securely stored on site. The total amount of waste accepted to site must not exceed 1000 tonnes per year. According to the waste return submissions for 2022, Gibbon Equipment Hire accepted a total of 67.54 tonnes and removed 67.54 tonnes of sewage effluent which is within their annual permitted allowance.

Site infrastructure

During the site inspection, there was no cause for concern regarding the site infrastructure. The floor surface was in good condition with some pooling of water however there had been heavy rain the previous day (as seen in photo 2). Site security was not an issue due to fencing located all around the premises. The interceptor drainage system was fully operational with no concerns identified.

Technical competency

The allocated Technically Competent Manager (TCM) for the site is Miss Helen LLOYD. A copy of WAMITAB certificates has been provided.

Waste Returns submissions

These appear to be up to date and correct, the latest waste return for Q4 2022 was submitted on 20/01/23. Waste code accepted: 150107 & 191205, totalling 35789.13 tonnes. 827.2 tonnes were removed from the site as waste, coded as 191212, 191205 & 150107 and sent to landfill sites and glass recycling. The permit stipulates a maximum tonnage of waste to be accepted at the site per year at 220,000 tonnes. Please continue to submit quarterly waste returns within one month of the end of each quarter, in line with your permit.

No permit non-compliances were identified on this visit and thus no breaches have been scored.
