4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine site inspection at Rowan Foods. Officers were met by the new Head of Health, Safety and Environment and the Head of Engineering who accompanied them around the site.

Officers inspected the Effluent Treatment Plant (ETP) and were given an overview of the ETP process by site operatives. Waste from the ETP was coded as EWC 020204 and is currently being sent offsite to an Anaerobic Digestion (AD) plant.

The operator provided evidence (inspection report, photographs) to show that weekly spot checks were being completed at emission point W1.

Waste materials were stored appropriately and there were no odours, dust or noise observed at the time of the inspection.

The Head of Engineering provided a brief overview of the digital management system which is used to schedule monitoring, manage the Planned Preventative Maintenance (PPM) schedule and track actions.
