## 4. Details of our assessment

### **Milford Haven: Energy Kingdom – Hydrogen Refueller**

Pembrokeshire County Council have embarked on a renewable energy project (Milford Haven: Energy Kingdom (MH:EK)) exploring the role hydrogen could play in a decarbonised energy future.

The project includes the production of Hydrogen gas to fuel two Riversimple Rasa hydrogen fuel cell electric vehicles. Production of the Hydrogen is via zero emissions green electrolysis which is held securely in gaseous form in gas storage cylinders prior to dispensing into the hydrogen vehicles.

### **Compliance Assessment**

The operator is required to submit a report on the performance of the activities over the previous year by the 31<sup>st</sup> January. The operator submitted their annual report on the 17<sup>th</sup> March 2023; outside of the specified reporting window.

**As a result of this reporting failure, a non-compliance score of C4 has been recorded against G4 – Reporting and notification to Natural Resources Wales.**

Following assessment of the annual report, the subsequent observations were noted:

- The facility produced 53kg of Hydrogen between July 2021 and February 2022 utilising 3m<sup>3</sup> of mains water and 11MWh of electricity.
- Hydrogen production dropped to 10.24 kg for the FY2023 utilising 15m<sup>3</sup> of mains water and 14.1MWh of electricity.
- The process does not appear to have run as efficiently during FY2023, with a diminished hydrogen volume compared to elevated mains water and electricity usage.
