3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

An unannounced visit was made by David Ellar (NRW Senior Waste Regulation Officer) in response to an incident report relating to alleged unpermitted waste activity at the site (Incident WIRS 2302178).

During the visit David Ellar was accompanied around the site by the TCM Andy Evans. The weather was fine and dry.

A full site inspection was not undertaken at this time due to officer being there for incident response and not routine regulatory work, the following noncompliance's were however observed:

Leaks and Spillages

Condition 5.1.4 states that in the event of any potentially polluting leak or spillage occurring on site, documented control and remediation procedures shall be implemented immediately and recorded and shall meet the standards specified in Table 5.1. Action d) of Table 5.1 refers to the control and remediation of leaks and spillages. Major spillages of oil, fuel or other end of life vehicle fluid which are causing or are likely to cause polluting emissions to the environment.

- Immediate action shall be taken to contain the spillage and prevent liquid from entering surface water drains, water courses and unsurfaced ground.
- The spillage shall be cleared immediately and placed in alternative appropriate containers.
- The agency shall be notified immediately.

During the visit a large quantity of oil was observed on the ground under and behind a blue container close the treatment shed near where drainage works are being undertaken. This spill had not been cleared up in accordance with the permit. Evidence suggests that a quantity of this oil had been pumped out over the site boundary bund and on to land belonging to Wales and West Utilities. ARL will have to contact Wales and West Utilities (contact details given) to facilitate the clean up and recovery of oil released onto their land.

This has been scored as a Category 2 breach of permit condition 5.1.4 as it poses a significant risk to the surrounding environment.

ACTION – Ensure that all oil spills are cleared in a timely manner and in line with the above conditions as written in the EMS. ARL are to contact and agree clean up of oil released from site on to Wales and West Utilities land with Wales and West Utilities.

Directly applicable legislation

Under the Environmental Protection (Miscellaneous Amendments) (England and Wales) Regulation 2018, (directly applicable legislation) Condition A requires the operator to manage and operate a waste operation in accordance with system that minimises the risk

of pollution arising from the waste operation.

The root cause of the issues identified during the inspection stem from a failure in staff competency and a failure in following the procedures set out within the EMS, including storage methods and oil spillage procedures. **This has been scored as a Category 2 Breach of directly applicable legislation.**

ACTIONS- Ensure that EMS procedures are followed to minimise the risks of pollution from site operations and ensure that staff have the competence to manage the site and understand the requirements of the permit and EMS.

Natural Resource Wales will be considering its enforcement action for the above permit breaches.
