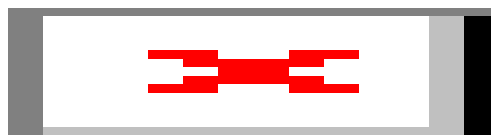
4. Details of our assessment

Introduction

Waste Regulation Officers Amy Bailey and Jodie Baskerville met with Lewis Campbell of Scott Waste. The site Manager and permit holder, William Scott was not present. The visit was an unannounced site inspection of the Standard Rules permit, ref- AB3292CD.

Throughout the duration of the inspection the weather was sunny and dry.

Following each compliance visit NRW will produce a Compliance Assessment Report (CAR) detailing comments from the inspection. If NRW substantiate reasonably foreseeable risks or actual impact to the environment, non-compliances will be scored against the conditions of the permit. These non-compliances are scored on a Category 1 – 4 basis:



- 1 – A non-compliance that could have a major environmental effect
- 2 – A non-compliance which could have a significant environmental effect
- 3 – A non-compliance which could have a minor environmental effect
- 4 – A non-compliance which has no potential environmental effect

Site Infrastructure

The site is exceptionally well run and organised.

All areas of the site were clean and tidy, and the yard surface was in very good condition.



Internal storage bays are well designated and easily identifiable. Officers did observe some additional tins of paint surrounding the designated storage tank, preferably this should be stored in a box to contain any potential spills.



The site has an interceptor, this was not inspected as part of the visit. Officers were informed that the interceptor is emptied by Redwood, an invoice couldn't be located at the time of inspection but has since been sent to Amy Bailey dated 31.3.23.

The site has adequate security measures in place including CCTV, alarm system and security lighting.

Site records

The office admin is very well organised, records in respect of waste movements and site diary were inspected and of the appropriate standard.

The site diary was available for inspection, was kept up to date and had records of relevant events.

Written Management System

Officers viewed the Environmental Management System, a copy of which was readily available.

Technically Competent Person

Sufficient records for the Technically Competent Person, William Scott were observed (WAMITAB and continuing competence certificate).

Waste Returns

Waste returns were up to date and officers were able to view the waste transfer notes which are well organised in a filing cabinet in the site office.
