REINSTATEMENT OF GROUNDWATER MONITORING BOREHOLES

On the 10th February 2023 The following request was made regarding the reinstatement of groundwater boreholes at the site:

Boreholes M19, M20, M21 and M22 have not been monitored in 2020 - 22 due to access issues. Boreholes BH1, BH18, M31, M34 and BH35 recorded levels below detection (<0.41mg/l) for ammoniacal nitrogen.

ACTION: Please can you submit an action plan to re-establish access to these boreholes or give a good reason why this cannot be actioned within 6 weeks of the date of this e-mail.

Following an inspection of the site on the 04th April 2023 I can confirm that the boreholes have now been reinstated to the satisfaction of NRW and no further action in this regard is required.
