Photograph obtained. The meter reads in m³ and so 7447 relates to 7447m³ being used since 2015.

Annual permitted use is 10,000 m³ and so you are well within your required abstraction limits.

I note however that the names recorded in the permit under **9.1 further conditions** do not name the current partnership and so in order to comply as required under section 9.2 which states ' any changes should be notified in writing to NRW' you must write and notify us of the current partners.

Further to this, **permit condition 8 Records** states that 'the Licence Holder shall take and record readings of the meter specified in condition 7.1 and at the same time each day during the whole period during which abstraction is authorised or as otherwise approved in writing by the NRW'

You must record the meter readings on a regular basis and record it for inspection by NRW if required.

I spoke with the groundsman and suggested keeping readings in a book in the office. This will ensure compliance with the permit.

I have not breached you on this occasion for failing to comply with the conditions outlined in this report, I am providing advice and guidance so please ensure you comply by notifying NRW of the new committee/partners and that records are kept of meter readings
