On 20th July 2018 my colleague and I carried out a routine inspection to assess compliance with your Abstraction Licence.

Part of this inspection involves checking your records. On 6th July 2018 your records indicate a daily abstraction volume of **114 m3**.

Your licence states "the aggregate quantity of water authorised to be abstracted under this licence..... shall not exceed **100 cubic metres** per day".

This is a breach of your licence conditions. On this occasion Natural Resources Wales does not propose to instigate any enforcement action. However, if further licence breaches occur, NRW may take enforcement action against you and this breach may be reconsidered.
