Visit Report/Comments

Environment Officers Kirsty Lewis and Martyn Davies visited Glamorganshire Golf Club 07/08.2018 to inspect Abstraction Licence 21/58/11/0009. The Head Greenkeeper proceeded to take us to the abstraction point. The abstraction National Grid Reference was in the correct point as stipulated by the permit with its use solely for spray irrigation of the golf course with abstracting only allowed to take place April to October.

Upon inspecting the pump. The greenkeeper informed us the pump would be upgraded in a few months time but remains fully operational without any issues. The meter was fully accessible although the meter dial needs to remain free from debris i.e dirt. With the reading 8279,18. On arriving back at the offices, records were inspected with quantities logged. Logs in which supports the meter reading. The maximum amount of abstraction is not more than 9,100 cubic metres per year. This shows this site is within compliance of their permit.

Actions

1. Ensure the meter is free from debris
2. Continue to record abstraction readings. In the event no abstraction is recorded Nil return can be entered within the record.
3. Continue to be compliant.
