Leachate Management

The treatment plant has been running intermittently since February, and data has only recently been provided on volumes which may have been discharged to sewer. Daily reporting figures (m3) are required.

Leachate level - as a result of LTP downtime and from the dip data, average leachate levels in LWEE are out of compliance. Please continue to monitor leachate level on a weekly basis.

These are significant on-going non compliances, which together with lack of reporting is causing concern and considered CCS2. A Regulation 36 Enforcement notice was served on 17th Dec 18 for CCC oo comply

with thier permit conditions by taking specified steps.

An Action Plan with timescales has since been provided.

UPDATE from site meeting and inspection on 17th May

LTP is reported as being operational on a daily basis. Discussion with DCWW on discharge volumes vs concentrations. Whilst operations have improved, this is an ongoing item and leachate management and compliance will be kept under review. Due dates superceded.

Separate discussion on Solar Farm, CQA Validation Report, PRTR and Post Closure monitoring and Aftercare requirements.
