4. Details of our assessment

Q1 2023 (January - March) monitoring results were submitted to NRW on 06 April 2023 in accordance with Condition 4.2.3.

1. Air Emissions

Emission Point A1 Continuous air emissions monitoring (CEMS) was undertaken in accordance with Condition 3.2.2

- No Half Hourly or Daily Average Environmental Limit Values (ELVs) for Hydrogen Chloride, Ammonia, Total Organic Carbon, Oxides of Nitrogen, Sulphur Dioxide, Nitrous Oxide and Particulates were exceeded during Q1 in accordance with Condition 3.2.2.
- Air A1 Daily Average for 17 and 22 February 2023 reported as non-applicable and 18 to 21 February reported as off. This was as a result of a boiler tube failure.
- Emissions to air (Emission Point A1) for Carbon Monoxide show no 10 minute (ELV 95th percentile) or Daily Average ELV exceedances in accordance with Condition 3.2.2.
- Emissions to air (Emission Point A2 - Emergency Generator) for Carbon Monoxide was undertaken on 3 March 2023 in accordance with Condition 3.6.1
- Stack emissions monitoring was undertaken in accordance with Condition 3.6.1 during March 2023. All results were below the ELVs.
- Residues Bottom Ash and Air Pollution Control residues sampling was undertaken in accordance with Condition 3.6.1. Bottom Ash composition for Q1 remained below the 3% TOC limit at 1.6% in accordance with Table S3.4 of the Permit.

Plant operating hours year to date; 2,018 hours were recorded with no periods of abnormal operations.

3. Schedule Notifications

A Part A Schedule 5 Notification was received on 18 February 2023 relating to a first pass boiler tube failure causing increased pressure within the combustion chamber resulting in expansion flaps opening intermittently. This resulted in an unauthorised release of high pressure steam and flue gas at 17:30 on 17 February 2023 for a period of 13 seconds. The plant was taken out of service to allow repairs. Diversion of waste was not deemed necessary.

The Part B was submitted on 23 February 2023 confirming the above fault. The boiler tube was replaced and the boiler came back on line at 05:48 on 22 February 2023.

No further actions are required following the Operators internal investigation.
