### 4. Details of our assessment

This CAR form is being issued as a result of pollution incident number (WIRS) 2302285 that was self reported by Dwr Cymru on 27/3/2023.

After seeing the photographs for this incident, Natural Resources Wales classified the incident as an "Event" as there was no visible impact on the beach. However, this is the second time that problems have come to light with this sewage outfall in recent years. A previous CAR form was issued in 2020 regarding this (CAR\_NRW0037044).

As this outfall is located on a beach which is a designated under the Bathing Water Directive / UK Regulations, this outfall needs to be in good condition and the effluent needs to reach the permitted discharge point so that the effluent can be diluted and dispersed appropriately. This is needed to protect bathing water quality and bathers health.

Should this incident have happened during the bathing water season a higher level of enforcement would have been considered appropriate.

It is understood that a repair to the pipe has been attempted, but failed. It's understood that another repair is to be attempted shortly. This should deal with the issue in the short term, however how about the long term?

Please respond to this CAR form with appropriate comments regarding looking at the condition of the pipe and how you propose to ensure that the discharge reaches the permitted point from now on. That is, a plan for the maintenance, or replacement etc of the pipe.
