### 4. Details of our assessment

This Compliance Assessment Report has been raised to review the resubmitted 2021 Annual Report. Natural Resources Wales (NRW) regulatory officer, Paul Challender identified issues with the previously submitted report in addition to issues with some quarterly monitoring returns. A resubmission of the 2021 Annual Report was requested in CAR\_NRW0040721. The operator instructed a consultant to complete this work and an extension to the submission date was requested. The revised 2021 Annual Report was received within this new timeframe. The resubmission was a much improved document addressing permit conditions and reviews data trends etc...

The report includes the topographical survey that was submitted in the previously submitted version of the report. This survey is presented as a drawing on page 27 of the pdf document within the '*Drawings*' section. This drawing is listed as Torus-Bryb-04-01 Bryn Posteg Site Survey September 2021 in the Table of Contents. The title and drawing number are displayed on the drawing on page 27. This drawing however, states that the drawing was drawn by MPH of Torus Engineering on 21/7/09. There is no legend or revision data presented on the drawing.

The ISOPACHYTE 2021 - 2020 drawing states that it utilises another set of drawings to compare 2021 to 2020 however, the change layer appears to be overlain over the height data presented in Torus-Bryb-04-01.

As such NRW rejects the Torus-Bryb-04-01 drawing as an accurate record of the height data at Bryn Posteg landfill in 2021 unless the operator or their consultant can evidence the provenance of the data and a breach of permit conditions has been raised.

The operator is also reminded of the requirement to comply with permit condition 3.7.4.
