Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

A compliance sample taken by Natural Resources Wales of the **sewage** discharge on the 14th of February 2023 had a solids result of 40mg/l as compared to the permit limit of 30mg/l.

As a result of this failure, contact was made with you and a site visit was undertaken on the 7th of March 2023 to see the treatment plant and the discharge point.

The treatment plant was seen to be in working order and there was no visual impact from the discharge on the stream into which the treated effluent discharges.

It's understood that since the failure you've set up a service agreement with Kingspan to maintain the sewage treatment plant.

During the visit we discussed the permit limits on this discharge compared to the trade discharge permit. I've today e-mailed our permitting team to seek further advice on this front.
