An announced site inspection was undertaken at CWM Environmental on 10 March 2023. NRW Officers Sally Wakeford and Michael Launder were accompanied on site by Darren Saunders of CWM Environmental.

Paul Wakelin is the current TCM for the site. The certificate we hold on file expired on 17/08/2022. This has been marked as Action Only against criteria C1 - Staff competency and training.

ACTION: Send current WAMITAB certificate for Paul Wakelin for our files.

As CWM Environmental is a large company, you may want to look into other providers of the TCM qualification. NRW recognise two, one being Wamitab, the other being EU Skills. At present the black bag waste is being shredded and removed loose.
