On the 15th of August 2018 Environment Officers conducted an inspection of the Hydropower scheme on the Cwm Gu brook near Tretower, Abstraction Licence: **WA/056/0036/007**, Impoundment Licence: **WA/056/0036/009/V003**.

The inspection was preceded by a long period of dry weather. At the time of the inspection no abstraction was taking place, no water was flowing over the coanda. The hands off flow notch was clear of any blockages, 100% of water in watercourse was flowing through the notch.

Measurements and photos of the construction were taken and submitted to the Hydrology team at Natural Resources Wales to determine compliance with the conditions of the licence. **The weir was found to be compliant.**

We were unable to locate the turbine house.

Actions

Submit 12 months of abstraction data to the contact details below within **28 working days**.

Confirm the location of the turbine house and that the discharge pipe is fitted with a wire mesh, maximum 10mm spacing.
