Audit: Pre-acceptance, Acceptance, Storage and Treatment - Jan. 2019

The actions are summarised below - please refer to full audit report appended separately.

Action 1 January 2019: *Tradebe to explain why cyanide is not a mandatory test at either pre-acceptance or actual site acceptance. Is the operator satisfied that cyanide bearing wastes are either not accepted or cyanide content is sufficiently low, that even under pH conditions of <8, there is no danger of HCN formation and volatilisation?* **Due: 31st March 2019**

Action 2 January 2019: *Tradebe to explain what testing is carried out in the main laboratory, as stated in para. 4.7 of procedure: PGRH 101.* **Due: 31st March 2019**

Action 3 January 2019: *Can the operator confirm if the gas cylinders are stored upright and are protected from sunlight heat source or justify why this is not necessary.* **Due: 31st March 2019**

Action 4 January 2019: *Can the operator confirm if the site rejection procedure includes reference to the dedicated quarantine area and that the quarantine area is sized adequately and protected from the contents of other reception areas.* **Due: 31st March 2019**

Action 5 January 2019: *Tradebe to confirm if customers are provided with guidance that makes it clear to them what wastes Tradebe cannot accept and therefore should not pack up.* **Due: 31st March 2019**

Action 6 January 2019: *Operator to explain the basis of the mixing threshold criteria: rise in temperature of receiving tank to greater than 45 deg C.* **Due: 31st March 2019**

Action 7 January 2019: *Operator to confirm what procedures, precautions and controls they carry out in order to detect, prevent or minimise acceptance of and discharge of wastes containing Cd, Hg, PCBs and POPs.* **Due: 31st March 2019**
