4. Details of our assessment

On Tuesday 28th March 2023 Officer Chris BURGE attended at Whites Recycling Ltd, located at Grosmont Lagoon, Wood Farm, Grosmont, Abergavenny, NP7 8LB, permit number, EPR AB3398HE. Officer Burge met with Ms. Anita SMART (Farm Liaison Manager) and Contractors KCP to look at

the cleaning operation taking place ready for a permit surrender to be submitted. The weather was wet and cold.

Ms Smart and KCP contractor explained the cleaning process to Officer Burge. The process involved a person moving a suction hose around in the bottom of the lagoon and washing the slurry residue out, the solution was then sucked up via a suction tanker and stored in a holding tank which allowed Whites Recycling tankers to arrange removal and remove the waste from site.

KCP explained that it would take them approximately 5 days to completely clean the lagoon to a standard NRW would consider acceptable. And expect to be finished by 4th April 2023.

Image two shows KCP Contractor in the lagoon conducting the cleaning process, it was observed that the liquid is no more than 10-15 cm deep so very minimal amount left.



On Tuesday 4th April Officer BURGE received an email from David Carr confirming that the cleaning had been completed and the lagoon was empty.

Whilst onsite Officer Burge was introduced to the landowner and farmer , the farmer explained he had requested that Whites Recycling do not fill in the lagoon as he would like to keep this to use as extra storage for his own slurry store for the dairy farm he owns and runs, this would not require a permit.

All waste returns are up to date and have been submitted on time.

NRW consider the above findings will meet the criteria of a low-risk surrender.
