4. Details of our assessment

LW met Darren Jones on site for a routine site inspection. Mike Parker wasn't available but DJ is the site TCM. DJ's continuing competency is valid until the 7th of May 2023. We discussed the current operations and the use of consignment notes for different producers.

The external EMS 14001 Audit is due in June 2023. I will be looking at the sites EMS fully in my next audit.

We discussed staff training and I was shown the training records which were all filed and up to date. We also discussed the air tests in the storage building. DJ sent me the air monitoring certificates which were all well below the thresholds required. This is done monthly by Anchem.

The transfer station was clean and tidy, the spillage kits were well stocked and the H type vacuum cleaner was up to date on testing. The storage for the asbestos is in a lockable container which is clearly labelled.

I inspected the procedure for the loading and storage of asbestos waste at the transfer station. The procedure gives details of how the consignment notes are completed and consignee returns are submitted to NRW.
