4. Details of our assessment

Following the Schedule 1 Notification of a coolant spill on 24th January 2023 and the issuing of CAR_NRW0041308, Continental were required to complete the following actions. Responses were received by the due dates.

Action 1: Continental to review all their procedures for the Control of Contractors for all aspects of the operation and update and improve them as necessary. NRW to be informed of the outcome by 12th April 2023.

The procedure has been reviewed and revised. Roles and responsibilities are clearly defined and a section requiring finished work to be checked by Continental personnel has been added.

The procedure is accepted. **Action 1 has been completed and can therefore be closed.**

Action C1: Provide NRW with evidence that training and supervision for operators in areas new to them, or for new operators, has been improved. Due date 31st March 2023.

The "New Employee Induction/Change in Department" form has been reviewed and improved. It includes a general induction section and then specific requirements for each department.

The form is accepted. **Action C1 has been completed and can therefore be closed.**
