3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On Thursday the 23rd of March 2023 Natural Resources Wales officers attended the site.

This was an unannounced routine inspection.

Site manager Darren Massey was present during the inspection.

Attendance of a Technically Competent Manager was discussed. There is a minimum site attendance of one hour a week on all operational sites. This includes in-house facilities taking their own waste. A week runs from Sunday at midnight and ends on the following Sunday at midnight.

NRW has been informed that the site now operates under a T9 exemption.

In order to use your exemption **only**, you need to ensure that any waste streams which are **not covered** by the exemption (for example ELVs) are not accepted, stored or treated on site.

We consider that a site is operational when it is either **accepting or removing waste, or undertaking any process or activity involving waste** that should be under the day-to-day control of a technically competent manager. If the facility is non-operational (zero operational hours) site attendance is not required.

At the time of the visit there were ELVs stored on site. Please see attached photos.
