4. Details of our assessment

During an inspection by Natural Resources Wales (NRW) on 10th February 2023 the following containment issues were noted and corrective actions B1 and B4 were raised in CAR_NRW0041425.

A corrective action relating to the submission of a partial surrender for the drumbrake area of the site was also raised.

Action B1: Send photographs of the bund repair to NRW **by 31st March 2023.**

Photographs of the repairs to the bund were received on 29th March 2023.

Action B1 has been completed and can therefore be closed.

Action B4: Send photographs of new IBC and banded pallet to NRW **by 28th April 2023.**

Photographs of the new IBC and plastic banded pallet in situ were received on 19th April 2023.

Action B4 has been completed and can therefore be closed.

Action A1: Partial surrender of permit to remove drumbrake area of site. Application to be received preferably **by 28th April 2023.**

Owing to pressure of work, ZF will not be able to submit the partial surrender by the required date.

NRW have agreed to extend the due date by two weeks. **The application must be received by 12th May 2023.**
