## 4. Details of our assessment

Self report provided on 13/03/2023 to NRW of a pollution incident to watercourses on 13/03/2023 downstream of Swansea Road (GCN) discharge point (Activity A7, SO 01451 07307) as a result of rainfall overwhelming storage and siltbuster capacity leading to contaminated water (high in suspended solids) entering the watercourse.

Surface Water Incident Report submitted by Sam Taylor to NRW on 14/03/2023 states the following measures were taken:

- Existing site excavations have been allowed to fill to reduce volumes entering the watercourse
- Teams deployed to site to maintain water management measures
- All earthworks stopped on site
- Further review of clean water ingress to site ongoing to identify opportunities for improvement
- Upstream measures (e.g baffles, bunds, flock matting) to be reviewed and improved
- Siltbuster engineers to visit sites to optimise dosing/treatment rates.

### Actions

- The water quality discharge permit measures suspended solids in mg/l (measured after drying at 105°C) whereas results for reports are submitted for Total Dissolved Solids (TDS) and Turbidity (NTU). In order to remove any ambiguity in future, please can all water quality reports include those parameters as permitted or provide a suitable documented method of conversion.
- Ensure there is sufficient storage capacity and/or treatment/mitigation for site runoff water to prevent foreseeable incidents.
- Ensure storage lagoons are desilted regularly where conditions permit to maximise water holding capacity.
- Carry out daily downstream watercourse checks to ensure most if not all site runoff water is being captured by the site water management.
- All actions to be implemented by 30/04/2023.
