4. Details of our assessment

Form S1, Emissions to Sewer, 1st January to 31st March 2023, was received on 20th April 2023. The average daily discharge was 35.8m³ over 59 days, making a total discharge of 2,111m³. The total discharge and daily discharge were lower than in Q4 2022 and the site operated for fewer days. The report is accepted.
