4. Details of our assessment

The Fugitive Emissions Summary Report 2023 was received on 21st April 2023.

The report is accepted.

This report reviews permitted emissions to air and water and ambient emissions of lead to air from the site. Ambient lead concentrations in air are measured at two locations and both show average annual concentrations less than the statutory air quality standard.

There were two exceedances of the emission limit value (ELV) for emissions of lead to water. Both occurred after the interceptor was cleaned on 1st July. The interceptor had been left closed and so it would not have been possible for any actual emission to surface water. All the other results were less than the ELV.

This report demonstrates that the fugitive emission controls used by EnerSys are effective and that their environmental monitoring is suitable and sufficient.
