Summary

This OMA (Air) follows the 2016 OMA, where the operator scored: overall 83%. The lowest scoring element was OMA4 Quality Assurance, particularly elements 4B (3 / 5), 4D (2 / 5) and 4E (1/5). This OMA just focuses on these three elements. The monitoring programme for the site is limited in both emission points and parameters and the monitoring is carried out by MCerts accredited contractors and with external analysis sent to UKAS laboratories accredited to ISO 17025.
